COMPREHENSIVE PLAN AMENDMENT #OA-20-01

To add to the Cultural Affairs, Arts, Tourism and Economic Development sections of the 2014 Comprehensive Plan.

Add the title of "Tourism-Hospitality to page 60 of the plan. Under the title add the following language "Within the limits of the City of Petersburg there are currently twenty (20) businesses that offer hospitality accommodations, including hotels, motels, Inns, and Bed and Breakfast establishments. None of the existing hospitality offerings have facilities to accommodate events (banquets, reunions, weddings, business meetings and conferences) and the demand for such accommodations is being met outside the City."

Add under the Economic Issues section of the plan, page 98, an additional bullet with the language "There is a lack of hospitality options to accommodate events (banquets, reunions, weddings, business meetings and conferences). Also, demand for accommodations to meet the needs of visitors and tourists is not met by current offerings."

Add an Objective 10 to the Policy Goal II section on page 99: "Objective 10: Identify and support efforts to provide diversified hotel options to accommodate events, business travellers and tourists."
