2. Closed Session
The purpose of this meeting is to convene in the closed session pursuant to:
 - a. §2.2-3711(A)(7) and (8) of the Code of Virginia for the Purpose of Receiving Legal Advice and Status Update from the City Attorney and Legal Consultation Regarding the Subject of Actual or Probable Litigation and Specific Legal Matters Requiring the Provision of Legal Advice by the City Attorney, Specifically Including but not Limited to Discussion of a Disputed Claim Concerning Stormwater Utility Payments; the Legal Requirements of 58.1-4109 and 2.2-4300 ET. SEQ. of the Code of Virginia; Virginia Attorney General Opinion 2010 VA. Pursuant to 2.2-3711(A)(3) of the Code of Virginia for the Purpose of Discussion or Consideration of the Acquisition of Real Property for a Public Purpose and the Disposition of Publicly Held Real Property Where Discussion in an Open Meeting Would Adversely Affect the Bargaining Position or Negotiating Strategy of the Public Body, Specifically Including but not limited to the Acquisition and Disposition of Real Property; and

c. Pursuant to 2.2-3711(A)(29) of the Code of Virginia, for the Purpose of discussing the Award of a Public Contract Involving the Expenditure of Public Funds, Including Interviews of Bidders or Offerors and Discussion of the Terms or Scope of such contract, Where Discussion in an Open Session Would Adversely Affect the city's Bargaining Position or Negotiation Strategy.

Ms. Lowery is concerned that a casino would take business away from small businesses and non-profits.

Mr. Coleman expressed support for the casino because of the jobs and business it will bring to the City.

Ms. Chester thanked the Council for the improvements she has noticed in Petersburg and expressed her support for the casino and the tax revenue it will bring to support many city projects, including a new school.
