Tom Heidelman/Avram Fechter of PB Petersburg Owner LLC explained changes requested by the lender for the project and that 11 of the 49 lots slated for purchase have been deleted (following due diligence) because the lots are not suitable for houses.

No public comments.

Councilwoman Wilson-Smith noted that pages 188-189 did not reflect correct purchasers of the property and should be changed.

Motion for approval made by Councilman Myers with corrected information noted by Councilwoman Wilson-Smith.

Approved.

Councilman Cuthbert voted no, stating point of order because he believes the motion fails because it must have a super majority Council vote since the City owns Virginia Avenue School. The City Attorney was asked to provide documentation on this matter.

h. Councilman Myers noted typo, should be 352-53 University Boulevard, which economic development rep said would be correct.

Councilman Cuthbert and Councilwoman Wilson-Smith noted concern that some of the lots listed to be sold are not suitable for home construction. Developers explained that due diligence on the lots will occur during the upcoming months to determine if the lots are buildable. Councilwoman Wilson-Smith also said the Virginia Avenue School project should be underway before other properties are sold to the developer.

Approved.

Councilman Cuthbert and Councilwoman Wilson-Smith voted no.

- i. A public hearing for July 20, 2021, for the consideration to amend and readopt ordinance 14ORD24 regarding the procedure for citizens desiring to change the name of public and private streets in the City of Petersburg.
 City Attorney explained recommendation to make street name changes consistent with building name changes.
 No public comments. Motion was made and approved to further discuss at Council Retreat in August.

Rehabilitated Real Estate Located in the Atlantic Coast Line Railroad Commercial and Industrial Federal and Historic District.

Overview presented by Brian Gordineer, City Assessor. No public comments. Approved.

- Requesting adoption of an ordinance revision to make the duration of the New Residential Tax Credit Exemption (Sec. 106141 through 145) five years to be consistent with all other real estate exemptions.
 No public comments. Approved.
- m. A public hearing, second reading, and consideration of adoption of an ordinance to adopt section 74213 of the city code prohibiting the possession, carrying, or transportation of any firearms, ammunition, or components thereof in specified public places.

Councilman Cuthbert proposed change. It was notes that VA code changed in 2020 allowing localities to determine possession of firearms, etc. in specified public places.

Public Comment:

Ron Moore, member of Petersburg Planning Commission, stated that he feels this change would violate his right to bear arms and asked that Council table for additional research/discussion.

Denise Tipton of Studio 7 stated the need for the public to better understand this law.

Councilman Cuthbert made motion for approval. There was no second, so motion died.

Following additional discussion, Councilman Cuthbert made a motion to table and discuss at the Council Retreat in August.

Approved.

Public Information Period

A public information period, limited in time to 30 minutes, shall be part of an Order of Business at each regular council meeting. Each speaker shall be a resident or business owner of the City and shall be limited to three minutes. No speaker will be permitted to speak on any item scheduled for consideration on the regular docket of the meeting at which the speaker is to speak. The order of speakers, limited by the 30 minute time period, shall be determined as follows:

- a. First, in chronological order of the notice, persons who have notified the Clerk no later than 12:00 noon of the day of the meeting,
- b. Second, in chronological order of their sign up, persons who have signed a signup sheet placed by the Clerk in the rear of the meeting room prior to the meeting removed from consent agenda.

Marcus Squires

Thanked Parks & Rec for Jefferson Street Park Clean-up Day Asked for City plan for former Titmus building & Peabody School complex – There are no completed plans at this time.

Noted inspection needed for building safety at bathhouse at Willcox Lake and requested presentation on the safety of the dam at Willcox Lake.

Stated that Cooper field should be considered for a dog park.

Asked about Hill Community Center plan – there is no completed plan at this time.

Noted that Walnut Hill business district needs to be kept alive.

Commented that former vacant hotel at Wythe and Crater not a good image coming from Battlefield into downtown area.

Ron Moore

Suggested city consider using inmates to keep parks clean and cut grass throughout city and cemetery.

JaVonni Brustow

Stated that he does not like virtual meetings and asked that videos of council meetings be publicly posted.

Commented that public comment period is not transcribed correctly in council minutes.

Cory Harris

Stated that poverty should be the City's top priority.

Mary Howard

Stated she is working with Southside Community and Housing Authority and rent relief is available through this organization.

Commented that it is time to open up Sycamore Street to Old Street.

Asked that the city manager move forward with hiring an Economic Development Director. Questioned if noise study, previously approved by Council, had been completed. Requested that noise ordinance be discussed at Council retreat in August.

Asked city manager to include police chief in noise study. Expressed concern for grass growing on sidewalks and curbs throughout city. Requested that city manager and public works address this issue.

He also asked that if citizens see problems/crime, please report problems/crime.

Commended city manager for work to date.

- c. Presentation by City Manager on Sycamore Street Old Towne Square
 The city manager presented three options for the Square area located on Sycamore
 Street between Bank and Bollingbrook Streets. He stated his presentation was made
 regarding research/data on economic benefits verses public safety concerns.

Option 1: Leave as it currently exists

Option 2: Reopen Sycamore Street

Option 3: Reopen Sycamore Street and explore other options for opening an outside dining/gathering/entertainment area at the corner of Bollingbrook and Sycamore Streets. This option also included developing a master plan with Main Street for Downtown/Old Towne.

Councilman Cuthbert stated he preferred Option 2.

Councilwoman Wilson-Smith explained that while she had supported keeping Sycamore Street closed, following the presentation she supports Option 3 based on the data and extensive thought process presented by the city manager.

Councilwoman Smith-Lee commended the city manager for a presentation made on facts and not emotion and that she too supported Option 3.

Councilman Hill said he liked the city manager's presentation but would not give his thoughts since he owns a business in that area.

Councilman Myers stated that it was the city manager's decision on how to proceed with reopening Sycamore Street.

The city manager stated he will move forward with Option 3 and explore terms of leasing the lot at the corner or Sycamore and Bollingbrook Streets and bring back to Council.
